## **Psychiatrist Expands Practice To Meet Demand**

Seniora Matthews, MD, MPH, opened her first private practice, Hope Healing Behavioral Healthcare, in Helena, Arkansas in 2000.

The practice is a private, full-service mental health company that specializes in psychiatric care for children, adolescents, adults, and the elderly. Services include medication management as well as marital, family, substance abuse, and Christian counseling.

Dr. Matthews is the first African American female psychiatrist in the Eastern Arkansas area in private practice, making her services highly sought after by women and people of color. She goes beyond traditional medicine and also provides Christian counseling by educating patients on the importance of balancing the mind, body, and soul. She also helps clients by stressing the psychiatric benefits of exercising, eating right, and managing their finances properly.

In 2001, Dr. Matthews graduated from the Arkansas Women's Business Development Center's First Step FastTrac business training program. She also worked with alt.Consulting and received technical assistance in the areas of financial and personnel management

"I really learned a lot from the class and from working with a consultant," says Dr. Matthews. "One thing I needed was a feasibility study. I wanted to understand the East Arkansas market before expanding my practice.



I also learned a lot about legal issues, marketing, and cash flow management," she said.

Due to high demand for her services, she recently opened an additional location in Marianna. Her client load has grown from 20 to 200, a limit she has established in order to maintain the highest standard of patient care. Dr. Matthews was recently named the 2004 Minority "Service Provider of the Year" during the Minority Enterprise Development (MED) Week luncheon held at the Little Rock Regional Chamber of Commerce. MED Week is sponsored by the U.S. Department of Commerce's Minority Business Development Agency and the U.S. Small Business Administration.

Dr. Matthews is actively involved in civic and community services. She often accepts speaking engagements at health fairs, churches, and community centers. She is a member of the Arkansas Medical Society and the Arkansas Psychiatry Society and is a board member of the Lee County Cooperative Clinic. She recently served for three months in Operation Iraqi Freedom.

## Money Management: Christmas Without Crashing

As the end of the year approaches, it's time to think about what your tax liability to the IRS will be. A successful business rests on sound record keeping practices and a

solid cash flow. Without good records it is impossible to determine the financial condition or profitability of your business.

Complete and accurate record keeping is crucial to the success of your business for a number of reasons:

• Good records provide the financial data that helps you operate more efficiently, thus increasing your profitability. Accurate and complete records enable you to identify all of your business assets, liabilities, income, and expenses. That information helps you pinpoint both the strong and weak areas of your business operations.

• Good records are essential for the preparation of current financial statements, such as the income statement (profit and loss statement) and cash flow projections. These statements, in turn, are critical for maintaining good relations with your banker.

• Correct records are critical at tax time. Poor records could cause you to underpay or overpay your taxes. In addition, good records are essential during an audit if you hope to answer questions accurately and to the satisfaction of the IRS.

 Discuss your wish lists: Instead

of asking "What do you want this holiday?" ask, "What would make your holidays extra special this year?" While most kids often ask for toys and other material gifts, most kids will ask for a chance to bake cookies, make a snowman, or help with decorations. • Avoid charging your purchases: If you do charge, pay the bill on time to avoid finance charges.

• Pay Bills Early: When paying your December bills, some financial advisers suggest paying 20 percent more than the amount due for utilities and other monthly items. That way, you'll be a little ahead of the game in January, rather than feeling totally depleted after the holidays.

## The Myth About Free Money & Grants For Business

We continuously get asked about grants and free government money available to start a business or pay bills. Unfortunately these claims are bogus. The millions of dollars in "free money" that is supposedly available from the government just don't exist.

Yes, grant money is available from private foundations and government entities. No, it is not available to individuals to start a for-profit business.

Some companies sell "Free Money" books and seminars which is nothing more than a list of grant prospects you can write to request funding. Many of the listed sources do not offer grants to individuals, and some provide them only to non-profit organizations.

The information they sell you is available for free in any library, on the Internet, or directly from the government.

The bottom line is that there is really no such thing as "free" money for forprofit businesses. Don't get taken by these scam artists.
